SUBJECT:	Ontario Population Projections (2008 – 2036)		
RECOMMENDATION:	That the report titled <i>Ontario Population Projections (2008 – 2036)</i> , dated January 12, 2010 from the Commissioner of Planning and Building, be received for information.		
	The report titled "Ontario Population Projections (2008 – 2036)" from the Ministry of Finance was released on November 10, 2009. The report was sent to the Regional Municipality of Peel with a cover letter from the Deputy Minister, Ministry of Finance, and included as correspondence in the Regional General Committee agenda for December 3, 2009 (see Appendix 1). A copy of the full 100 page document can be found at the Ministry of Finance's website www.fin.gov.on.ca/en/economy/demographics/projections/demog09.pdf. The population projection for the year 2031 for the geographic area of Peel Region is 2,078,600 persons. The Growth Plan for the Greater Golden Horseshoe 2006, prepared and approved under the <i>Places to Grow Act, 2005</i> by the Ministry of Energy and Infrastructure (previously the Ministry of Public Infrastructure Renewal), provided a population forecast for the year 2031 for the geographic area of Peel Region of 1,640,000 persons. This is the figure currently being used for planning purposes, although the Ministry of		

Energy and Infrastructure has indicated that these projections are under review and that the projections by the Ministry of Finance will inform that review.

COMMENTS: The highlights of a comparison of the two sets of projections are:

- The Growth Plan for the Greater Golden Horseshoe, 2006 forecasted a population for the year 2031 for the geographic area of Peel Region at 1,640,000 persons;
- The Ministry of Finance population projection for the year 2031 for the geographic area of Peel Region is 2,078,600 persons as shown in Table 1 of Appendix 2. This is an increase of 438,600 persons compared to the Growth Plan for the Greater Golden Horseshoe;
- The Ministry of Finance releases yearly updates of the Provincial population projections (Table 2 in Appendix 2). The current release, Fall 2009, contains the first projections based on the 2006 Census. Previous year releases were based on the 2001 Census. Comparing Fall 2009 population projections to Spring 2006 population projections, it is noted that growth in Peel Region has been decreased between 2006 and 2011, while the Fall 2009 projection release shows an accelerated growth rate between 2011 and 2031;
- The City of Mississauga retained Hemson Consulting Ltd. to prepare a growth forecast in 2008 for the years 2008-2031. This report was submitted to Planning and Development Committee (PDC) on January 12, 2009. For the year 2031, Hemson projected a population of 812,000 persons for the City of Mississauga (see Table 1 in Appendix 2);
- The apportionment ratio between Peel Region's population and the City of Mississauga's population has declined during the period from 1996 to 2006, from 64% to 58% as shown in Table 3 of Appendix 3. If the population apportionment is used as a measure of potential impact, and using the apportionment based on Hemson's growth forecast of 49% in 2031, the forecast for the City of Mississauga would be approximately 1,018,500 persons by 2031 according to the

Ministry of Finance forecast. This would be an increase of approximately 206,500 persons by 2031 above the Hemson forecast in the High Growth Scenario of 812,000 persons as shown in Table 1 of Appendix 2.

- The impact of this population growth on the City of Mississauga would require greater investments in infrastructure and other services. This added growth could have a positive impact in terms of transit-supported development in the right location to achieve other city-building objectives; and
- The letter to the Regional Clerk stated that, "The projections use assumptions about births, deaths and migration determined through analysis of past and current trends. The projections do not represent government population targets and they do not incorporate explicit policy and planning considerations." The Ministry of Energy and Infrastructure has initiated a review of the forecasts in the Growth Plan for the Greater Golden Horseshoe, prepared and approved under the *Places to Grow Act, 2005* and that "In the meantime, the population and employment projections contained in the Growth Plan are to be used for planning for and managing growth. All decisions under *the Planning Act* must conform to the Growth Plan."
- **STRATEGIC PLAN:** Increased population in the appropriate location would be supportive of the strategic pillar for change in the City's Strategic Plan, "developing a transit-oriented city".

Also, in the "Complete Our Neighbourhoods" strategic pillar, Action 17 recognizes the need to increase our population target to fund and support new infrastructure.

FINANCIAL IMPACT: An increase in the City's population would impact the provision of infrastructure and services to accommodate increased growth. The details would be established when an actual figure is agreed upon.

CONCLUSION:	The Ministry of Finance has released updated population projections based on the 2006 Census with a significant population variance from the projections provided as part of the Growth Plan for the geographic area of Peel Region. These numbers will provide input for the review of the projections in the Growth Plan being undertaken by the Ministry of Energy and Infrastructure. Depending on the outcome of this review, the upper limit of growth for the City of Mississauga could be considerably higher than the figure currently being used for planning purposes. Staff will monitor the review process and report to Planning and Development Committee, as required.

Dear Ms. Gravlev:

I am pleased to let you know that the new Ministry of Finance population projections for Ontario and its 49 Census Divisions, 2008-2036, have been released. They can be found on the ministry's website at http://www.fin.gov.on.ca/en/economy/demographics/. A CD-Rom of the projections report and tables is enclosed.

Ministry of Finance officials analyzed the feedback from the municipal consultation held in August and the preliminary projections were fine-tuned. The final projections are based on the 2006 Census and replace projections based on the 2001 Census, last updated in Spring 2008.

These projections are developed to assist municipalities, government ministries and other agencies with their long-term planning. The projections provide detail by age and sex for every census division and for every year from 2008 to 2036. They represent the only publicly available set of population projections for the whole of Ontario where census division projections aggregate to the provincial total.

The projections use assumptions about births, deaths and migration determined through analysis of past and current trends. The projections do not represent government population targets and they do not incorporate explicit policy and planning considerations. They will be updated annually to provide users with projections in line with the latest population estimates from Statistics Canada.
