

## **Terms and Conditions:**

By submitting a library memory (the "Work"), I represent and warrant that: (i) the Work does not contain any material that is libelous, defamatory, profane or obscene; (ii) the Work is original and all right, title and interest (including copyright) in and to the Work is owned and/or controlled by me to the full extent necessary to enable the City to use the Work; and (iii) the Work does not infringe upon the intellectual property or other statutory or common law rights of any third party.

I agree that all copyright in my completed submission form and in any material depicting my likeness or other information about me shall be vested in the City and I hereby irrevocably assign all of my worldwide intellectual property rights in and to such entry form and materials to the City and waive all moral rights therein.

By providing the Work to the City, I shall retain all right, title and interest (including copyright) in and to the Work, and hereby grant to the City a worldwide, gratuitous, irrevocable, and exclusive licence to copy, use, modify, reproduce, display, adapt and transmit the Work for use in all media now known or hereafter devised in perpetuity beginning on the date of entry, including, but not limited to, in connection with the administration, promotion and exploitation of the "20 Years in 20 Words" book. I hereby confirm that the Work is an original work, solely created by me, and that no third party participated as an author, co-author or otherwise in the creation of the Work or any part thereof. The City assumes no responsibility for any claims of infringement of rights to copyright, privacy and/or personality, and all such liability shall remain with me. The City reserves the right to exclude any Work on the basis of concerns relating to the rights of third parties, including but not limited to privacy, copyright, defamation, rights of personality, obscenity or hate speech, as determined by the City in its sole discretion.

This Personal Information will not otherwise be sold or transmitted to third parties except to third-party agents and service providers in connection with the foregoing activities. By completing a submission form I grant my permission for the collection, use and disclosure of his/my Personal Information submitted to the City for the foregoing purposes.
