SUBJECT:

Applications for the Federal Infrastructure Stimulus Funding

(ISF)

- **RECOMMENDATION:** 1. That the report dated April 28, 2009 titled Applications for Federal Infrastructure Stimulus Funding (ISF) from the Commissioner of Corporate Services and Treasurer be received.
  - 2. That Council approve submission of applications for the ISF grant for the projects included in Appendix 1 having a total gross capital cost of approximately \$170 million.
  - 3. That staff report back to Council on projects approved for an ISF grant including necessary City capital contributions and additional project delivery costs.

#### BACKGROUND:

As part of Canada's Economic Action Plan, the Federal government established a new \$4 billion Infrastructure Stimulus Fund (ISF) that will provide funding to provincial, territorial, municipal, community and private sector construction-ready infrastructure projects. This fund focuses on short term initiatives for economic stimulus. Funding is available for two years for projects that can begin construction quickly and can be built during the 2009 and 2010 construction seasons.

On April 15, 2009, the Federal and Provincial Ministers responsible for Infrastructure sent out a joint letter to launch the application process for the Infrastructure Stimulus Fund as well as the Communities Component of the Building Canada Fund (BCF). Only municipalities with populations under 100,000 can apply for the BCF Communities Component. Since Mississauga does not qualify for the BCF Communities Component, this report will focus only on the ISF grant.

To ensure that the program provides economic stimulus quickly, the management and delivery of Stimulus Fund moneys are being tailored to respond to the unique conditions and priorities in each Province. Proposals from municipal and non-governmental organizations will be considered through different selection processes depending on the funding available in each province or territory. Provincial or Territorial funding will be provided based on a per capita allocation but will be re-allocated to federal infrastructure projects in provinces or territories where progress is slow, or provinces and territories are unable to match federal funding.

In order to move the process along quickly the application deadline for the program is May 1, 2009 and approved projects must be completed by March 31, 2011.

Criteria for grant application guidelines continue to be revised with the changes received late on Monday, April 20, 2009 and were incorporated into the presentation received by Council on April 22, 2009. In addition, a "Q&A" sheet was released on late on Monday April 27, 2009 which provides additional clarification on program criteria. The "Q&A" sheet clarified that although stand-alone recreation buildings are not eligible under this program, "recreational facilities such as swimming pools are only eligible where these are part of a larger construction or rehabilitation project for a multipurpose municipal building such as a community centre."

**COMMENTS:** 

In a communication received from the Association of Municipalities of Ontario (AMO) as well as information presented from the Federal Government, the revised general guidelines (received late Monday, April 20<sup>th</sup>) as well as specific mandatory criteria have been provided

regarding the eligibility for ISF grant funding. In order to meet the economic stimulus objective of senior levels of government, the entire grant process focuses on the need for quick construction. A summary of the guidelines and criteria are as follows:

- \* the funds are focused on the rehabilitation of existing assets (although new construction is eligible);
- construction must be completed by March 31, 2011 or else it may result in cancellation of any further funding and/or repayment of funds received to date;
- preference will be given to projects where 50% of the funds will be spent by March 31, 2010;
- each municipality can apply for an unlimited number of projects;
- federal, provincial and municipal contributions must each be an equal one-third of the eligible costs;
- ineligible costs include land acquisition, leasing land, buildings (assuming to mean outright purchase), equipment (stand alone purchases), legal or real estate fees, employee wages and benefits and any other direct or indirect overhead or administrative costs;
- project incrementally the municipality must attest that the projects would not have been built over the next two construction seasons without the federal and provincial funding;
- \* financial agreements must be signed between the Province of Ontario and the municipality;
- prior to final approval of funding and the conclusion of an agreement with the province, the municipality must provide proof of Council support for each approved project and the municipal contribution;
- recipients of funding for a project will be required to submit quarterly progress reports detailing the status and overall update of the project;
- if construction is not started within 60 days of the start date proposed in the application, the funding could be cancelled; and
- upon completion and prior to final payments from the federal government, a registered professional must provide a Solemn Declaration of Substantial Completion that projects have been completed by March 31, 2011. Completion is defined as "all

major construction work has been completed and the infrastructure is ready to be used for its intended purpose."

These requirements restrict projects which can be considered for the funding application. Project start and completion times in particular are of critical importance to qualify for this grant program.

Potential projects cover a variety of service areas that can be considered for the grant funding. Local government asset categories (eligible projects) identified under the ISF are:

- Water and Waste Water Infrastructure
- Public Transit Infrastructure
- Local Road Infrastructure
- Disaster Mitigation Infrastructure
- Solid Waste Management Infrastructure
- Brownfield Redevelopment Infrastructure
- Cultural Infrastructure
- Airport Infrastructure
- Port and Cruiseship Infrastructure
- Municipal Buildings
- Parks and Trails

#### **Application Evaluation Considerations**

Along with the above mandated criteria and eligible projects types, the required application that must be completed for these grant funds is fairly comprehensive. The application, sample attached in Appendix 3, asks very specific questions grouped into categories such as Project Benefits, State of Readiness, Environmental Considerations, Aboriginal Consultation, Funding, Construction dates and Attestation. Many of the application requirements such as project location details, projected costs and construction timing are all common and expected. The application goes into further specifics requesting the following information:

- Are plans and specifications prepared?
- Is project tender ready?
- \* Have all necessary municipal, provincial and federal permits

- and approvals been secured?
- Have all necessary environmental approvals been secured?
- Is the project located within 250 meters of a federal, provincial, or municipal environmentally sensitive area?
- Does the project involve the likely release of polluting substances into a water body such as a wetland, stream, river or lake?
- Are there Aboriginal groups or communities in the project area?

Each of these questions also requires a detailed explanation to further clarify the answer provided. Since to be eligible, a project would not have been constructed in the next two years without this grant funding, some of the responses and explanations may not be well developed as staff will not have done the necessary work this far in advance.

The guidelines for application have been re-defined/clarified such that there is no restriction on the number of applications but bundling of similar projects or programs is not permitted. It will be necessary to prepare separate applications for each location (e.g., a separate application for each park for the pathway lighting or each separate road repaving). Given this requirement, staff will be preparing almost 300 applications for submission worth an estimated \$170 million.

Taking into consideration all of the program requirements and restrictions, staff have reviewed projects which are of high priority importance and which can meet all of the grant conditions. The projects identified are able to meet the timing limitations and are not already included in the 2009 approved and funded capital program. Projects which require partnerships or joint agreement with other parties that have not yet been finalized were not considered in light of the additional time requirements usually associated with getting a third party agreement.

#### Project Implementation and Timely Delivery of Projects:

Based on the large number of potential new or accelerated projects, the City's capital workload will increase greatly and it will be very challenging to meet these tight timelines. To put this into some perspective, the City's average annual capital forecast over the next 10

years is about \$180 million annually. Should all of the proposed ISF projects be approved, it would be the equivalent of adding almost a full year's capital program to our existing workload over the next two construction seasons, representing almost a 50% increase in the planned capital projects which will be completed.

The strict timelines could have the following impacts:

- The time frame for public consultation on projects will have to be limited, and far less extensive than our normal practice;
- There will be an increased demand for consulting and project management resources given all municipalities in the GTA will be under the same completion deadlines which may affect contract pricing;
- \* There may be premium prices on certain materials and trades that are in demand;
- Inability to phase projects may see widespread and simultaneous construction throughout the City which may cause traffic disruption and complaints;
- There will be limited ability to relocate groups or services as facilities are renovated which may cause service interruptions;
- Parts or all of the project design and construction may have to be sole sourced to speed up procurement; and
- Administrative, consultation and approval processes will need to be fast tracked.

Depending on the projects approved under the ISF grant, resources in a variety of support areas will need to be augmented in order to meet the tight time lines and complete the entire process. In addition to project management and technical resources to complete the projects, additional resources will need to be added to ensure the projects are delivered within the City's by-laws and processes, etc. For example, the funding approval will impact procurement activities with increased volume, complexity and timelines. These may need to be expedited and fast tracked through single source contract awards.

Once the ISF funded projects are approved, the City will be in a better position to determine the additional project delivery costs. Additional staff costs are ineligible costs and can not be recovered from ISF grants. Additional staff resources will be needed in some or all of the

following areas: project management / administration, procurement, legal, finance and reporting, and communications.

#### Recommended Projects:

The following list of projects best meets the criteria and timelines of the ISF program and are listed in Appendix 1 – Summary of ISF Recommended Projects. Also, a listing of the more detailed locations has been provided in Appendix 2 - Detailed Listing of Projects Recommended for ISF Grant Application.

These projects have been selected because they primarily can be completed by March 31, 2011 and meet the other ISF program criteria. The list represents a good balance of "hard" and "soft" infrastructure services with a good mix of city-wide and local community benefits.

#### Other Projects Considered:

When evaluating the grant application criteria, consideration was given to the rehabilitation of the City's seven outdoor pools and three of its school pools. Stand alone recreational and sport capital projects are not eligible under the ISF program for municipalities with a population of more than 100,000 people. As these pools are considered stand alone recreational facilities, they will be covered under the Recreation Infrastructure Canada (RInC) funding program. The City is still awaiting guideline and application information regarding this process; however, it is limited to \$500 million in federal funding Canada-wide.

The ISF "Q&A" sheet released on April 27<sup>th</sup> did clarify the eligibility of indoor pools or gymnasiums, allowing these to be rehabilitated or constructed provided they are part of a larger project within a multipurpose municipal building such as a community centre with a library (for example). While this would make these proposed new pools at Malton and Clarkson Community Centres eligible, staff believe that we can not complete this projects by March 31, 2011 because the required planning work in not a sufficient stage of preparation/completion.

#### FINANCIAL IMPACT:

The ISF grant funds must be spent by March 31, 2011 on major infrastructure projects that are required but that would not otherwise proceed without this grant funding. The City will be applying for approximately 300 projects/locations costing almost \$170 million as detailed in Appendix 1.

The City is responsible for funding one third of the costs for the projects approved for grant funding. The total 1/3 cost will depend on which projects are approved under the application process. Capital reserve funds would be used to finance the City's portion of the projects. Depending on the mix of projects selected, the City may issue debt sooner or at a higher level than originally forecast. Upon notification of any successful applications, staff will bring a report forward to Council to identify the City's portion of the costs, to allocate funding required from the appropriate reserve funds and to identify any additional project delivery costs which are not eligible

under the ISF grant.

If all the recommended projects are approved by senior levels of government, then the total one-third municipal contribution is estimated to be \$56 million. This would lever a combined two-thirds Federal and Provincial grant of \$112million.

The City will also be solely responsible for funding any additional staff that will be required to deliver these additional projects should they be approved. While contracted project management services may be eligible costs, additional City staff are not.

#### **CONCLUSION:**

The \$4 billion Infrastructure Stimulus Fund has been made available to municipalities to focus on economic stimulus and to address much needed funding for maintaining aging infrastructure.

Staff have identified several projects that meet the criteria and strict timing restrictions to apply for the ISF grant funding. Staff will continue to complete the project details and refine the costing of the projects selected to be submitted as part of the May 1<sup>st</sup> application due date.
