Community Profile

History

The Credit River Valley was once the domain of the Mississauga's - a band of the Ojibway. In 1805 they relinquished most of their land to the British Government except for a one mile strip on both sides of the Credit River. As European settlement began in the 1900s, the Mississauga's sold most of their remaining land.

In the first half of the 1900s Meadowvale Village developed to serve the farming community. Many settlers moved through the area at Old Derry Road West and Second Line West. In 1819 the first Irish settlers arrived from New York led by John Beatty. In 1831 Beatty sold his land to James Crawford who, like John Simpson,

opened saw and carding mill operations along the Credit River. Francis Silverthorn took over and expanded Crawford's mill in 1844. In the same year, George Ball, a local blacksmith, built Meadowvale's first hotel. After Silverthorn fell into financial trouble, Gooderham and Worts took over his mills and prospered. The milling operations fell

into difficult times when the Grand Trunk Railway by-passed the village and went through Brampton - reducing Meadowvale Village to a farm service centre once again.

In the 1950s the area was designated for agricultural, residential and greenbelt uses. In 1968 Meadowvale joined with other villages to form the Town of

Mississauga. Due to the historic character of the area, Meadowvale Village earned the distinction of becoming Ontario's first Heritage Conservation District in 1980. Today, the Ball motel is used for apartments, the Mill ruins can still be seen, Silverthorn house is a private residence and Gooderham Estates mansion has been newly restored.






Figure 1. Population Pyramid





Statistics Canada assigns data for an enumeration area to a single representation point. Where these representation points occurred in close proximity to the boundary of a planning district, data may have been inappropriately assigned to the planning districts. Some reassignments of data to planning districts were made to correct this situation. This occurred most often for residential areas adjacent to an industrial area. Adjustments were made to the Statistics Canada population data based on adjustments to the dwelling unit allocations. When dwelling unit reallocations were made, the associated population were also reallocated.
